I, Gary A. Durr, am employed as a Paralegal Specialist with the Department of Justice and have been assigned to work in support of counsel for the United States in the above-captioned case.

A. Pursuant to the Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-area 7 of the Zuni River Stream System (Doc. No. 561), defendants in the Zuni River Basin Adjudication were sent a service packet that included a proposed Consent Order, Request for Consultation form, Notice of Water Rights Adjudication, a form Answer, and if the defendant had not been served process or had not voluntarily waived

such service, a copy of the Amended 2003 Complaint, a Request for Waiver of Service of Summons, and two copies of a Waiver of Service of Summons with a prepaid return envelope. The packet also included a letter from the United States explaining the purpose of the forms and to whom and when documents were to be mailed or provided if the defendant chose to respond. The documents were mailed to the defendants' mailing address or counsel of record via certified mail, return receipt requested.

B. The service packet for Antonio Sandoval, Jesse Sandoval and Sarah Sandoval (ZRB-3-0173), was mailed to the Defendants' address of record and although the date of delivery block on the return receipt is blank, the reverse side of the receipt is stamped by the United States Postal Service on June 14, 2006 indicating the packet was received by the Defendants on or about June 14, 2006. A copy of Postal Service Form 3811 is attached to this Declaration.
