1. The Court has jurisdiction over the above-named defendant as shown by the filed waiver of service of summons of WILLIAM CROOKS (Doc. No. 362).

2. WILLIAM CROOKS was provided the documents listed in the Declaration of Gary A. Durr (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-4-0109, Defendant WILLIAM CROOKS was subject to the Special Master's September 28, 2006 Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Areas 1, 2, and 3 (Excluding Ramah) of the Zuni River Stream System (Doc.
