1. The Court has jurisdiction over the above-named defendant as shown by

the filed waiver of service of summons of FRIEDA PETTIGROVE (Doc. No. 362).

2. FRIEDA PETTIGROVE was provided the documents listed in the Declaration of Gary A. Durr (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-4-0153, Defendant FRIEDA PETTIGROVE was subject to the Special Master's September 28, 2006 *Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Areas 1, 2, and 3 (Excluding Ramah) of the Zuni River Stream System* (Doc. No. 838)("Procedural and Scheduling Order"), which established a deadline of January 23, 2007 for the submission of a Request for Consultation or the return of a signed Consent Order.

4. These deadlines for Subfile ZRB-4-0153 were never extended.
