2. RHONDA S. VELKOVITZ was provided the documents listed in the Declaration of Gary A. Durr (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-4-0397, Defendant RHONDA S. VELKOVITZ was subject to the Special Master's September 28, 2006 Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Areas 1, 2, and 3 (Excluding Ramah) of the Zuni River Stream System (Doc. No. 838)("Procedural and Scheduling Order"), which established a deadline of January 21, 2007 for the submission of a Request for Consultation or the return of a signed Consent Order.
