1. The Court has jurisdiction over the above-named defendants as shown by

the filed service of summons on TIMOTHY H. POINTER (Doc. No. 2156) and PATSY

POINTER (Doc. No. 2156).

2. TIMOTHY H. POINTER & PATSY POINTER were provided the documents listed in the Declaration of Gary A. Durr (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-3-0131, Defendants TIMOTHY H. POINTER & PATSY POINTER were subject to the Special Master's March 7, 2006 *Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Area 7 of the Zuni River Stream System* (Doc. No. 561)("Procedural and Scheduling Order"), which established a deadline of August 12, 2006 for the submission of a Request for Consultation or the return of a signed Consent Order.

4. These deadlines for Subfile ZRB-3-0131 were never extended.
