- 5) State reported that field offices were going well receiving disclaimers/forms and pending new digts.
- 6) Discussion of timing of opening new digts.
- 7) U.S. stated that motion of Lis Pendens will be filed in the next few weeks.
- 8) Discussing methods and timing of service to digts.
- 9) Special Master advised would consider the framework for scheduling procedures on Indian claims used in the Santa Cruz / Tule Lake case; asked for suggestions on service and filing procedures proposed procedures to be filed with the court.
- 10) Special Master instructed U.S. to write a proposed order on schedule for June groundwater claims within two weeks.
