MOTION FOR DEFAULT JUDGMENT

The Plaintiffs United States of America ("United States") and New Mexico ex rel.

State Engineer ("State"), pursuant to Fed. R. Civ P. 55(b)(2), move the Court to enter its order

granting default judgment against the following defendants:

LISA BAEZA & LUIS BAEZA	Subfile No. ZRB-4-0113

and as grounds therefore Plaintiffs state:

1. The Court has jurisdiction over the above-named defendants as shown by

the filed service of summons on LUIS BAEZA (Doc. No. 1232) and LISA BAEZA (Doc. No.

1228).

2. LISA BAEZA & LUIS BAEZA were provided the documents listed in the Declaration of Khaleelah E. Jones (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-4-0113, Defendants LISA BAEZA & LUIS BAEZA were subject to the Special Master's September 28, 2006 *Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Areas 1, 2, and 3 (Excluding Ramah) of the Zuni River Stream System* (Doc. No. 838)("Procedural and Scheduling Order"), which established a deadline of January 12, 2007 for the submission of a Request for Consultation or the return of a signed Consent Order.

4. These deadlines for Subfile ZRB-4-0113 were never extended.

5. Defendants LISA BAEZA & LUIS BAEZA each failed to waive service of a summons. After being served with summonses, they filed timely Answers (Doc. Nos. 1261 & 1262) to the United States' Amended Complaint which made no reference to the Consent Order Plaintiffs offered to Defendants for Subfile ZRB-4-0113. Neither defendant has ever submitted a Request for Consultation or signed Consent Order concerning Subfile ZRB-4-0113.

6. Defendants LISA BAEZA & LUIS BAEZA are in default for failure to appear, answer, or otherwise defend in Subfile ZRB-4-0113 within the time limitations imposed by applicable Procedural and Scheduling Orders, or Orders of the Court extending deadlines, as shown by the Clerk's Certificate of Default filed August 13, 2009 (Doc. No. 2396).

7. In accordance with the *Zuni River Basin Adjudication Hydrographic Survey Report for Sub Areas 1, 2 and 3 (excluding Ramah)*, as amended, the right(s) of LISA BAEZA & LUIS BAEZA to divert and use the public waters of the Zuni River Stream System, Sub-Areas 1, 2 and 3 (excluding Ramah), should be as set forth below:
