# **MOTION FOR DEFAULT JUDGMENT**

granting default judgment against the following defendant:

and as grounds therefore Plaintiffs state:

1. The Court has jurisdiction over the above-named defendant as shown by

the filed proof of service of summons on DEWARD LANCE BOND (Doc. No. 2306).

2. DEWARD LANCE BOND was provided the documents listed in the Declaration of Khaleelah E. Jones (Exhibit 1) on the dates indicated.

3. With respect to Subfile ZRB-5-0066, Defendant DEWARD LANCE BOND was subject to the Special Master's January 11, 2007 *Procedural and Scheduling Order for the Adjudication of Water Rights Claims* (Doc. No. 954)("Procedural and Scheduling Order"), which established a deadline of June 13, 2007 for the submission of a Request for Consultation or the return of a signed Consent Order.

4. These deadlines for Subfile ZRB-5-0066 were never extended.

5.
