- 1. The Court has jurisdiction over the above-named defendants as shown by the filed Proof of Service of Process by Publication for Howard Price (Doc. No. 2379), and the waivers of service of summons for Donald J. Philippe and Tommy D. Hartsfield (Doc. No. 745).
- 2. DONALD J. PHILIPPE & HOWARD PRICE & TOMMY D. HARTSFIELD were provided the documents listed in the Declaration of Khaleelah E. Jones (Exhibit 1) on the dates indicated.
- 3. With respect to Subfile ZRB-3-0075, Defendants DONALD J. PHILIPPE & HOWARD PRICE & TOMMY D. HARTSFIELD were subject to the Special Master's March 7, 2006 Procedural and Scheduling Order for the Adjudication of Water Rights Claims in Sub-Area 7 of the Zuni River Stream System (Doc. No. 561) ("Procedural and Scheduling Order"), which established a deadline of June 12, 2006 for the submission of a Request for Consultation or the return of a signed Consent Order.
