### **MOTION FOR DEFAULT JUDGMENT**

The Plaintiffs United States of America ("United States") and New Mexico ex rel. State Engineer ("State"), pursuant to Fed. R. Civ P. 55(b)(2), move the Court to enter its order granting default judgment against the following defendants:

and as grounds therefor Plaintiffs state:

1. The Court has jurisdiction over the above-named defendants as shown by the filed service of summons by publication (Doc. No. 2379)

- 2. THE UNKNOWN HEIRS OF RALPH BOND were provided the documents listed in the Declaration of Khaleelah E. Jones (Exhibit 1) on the dates indicated.
- 3. With respect to Subfile ZRB-5-0011, Defendants THE UNKNOWN HEIRS OF RALPH BOND were subject to the Special Master's January 11, 2007 Procedural and Scheduling Order for the Adjudication of Water Rights Claims (Doc. No. 954)("Procedural and Scheduling Order"), which established a deadline of June 11, 2007 for the submission of a Request for Consultation or the return of a signed Consent Order.
  - 4. These deadlines for Subfile ZRB-5-0011 were never extended.
- 5. Defendants THE UNKNOWN HEIRS OF RALPH BOND are in default for failure to appear, answer, or otherwise defend in Subfile ZRB-5-0011 within the time limitations imposed by the Federal Rules of Civil Procedure, applicable Procedural and Scheduling Orders, or Orders of the Court extending deadlines, as shown by the Clerk's Certificate of Default filed January 19, 2010 (Doc. No. 2512).
- 6. In accordance with the Zuni River Basin Adjudication Hydrographic Survey Report for Sub Areas 1, 2 and 3 (excluding Ramah), as amended, the right(s) of THE UNKNOWN HEIRS OF RALPH BOND to divert and use the public waters of the Zuni River Stream System, Sub-Areas 1, 2 and 3 (excluding Ramah), should be as set forth below:
