This amended declaration is filed to correct the error of ownership reflected in the original declaration. In addition it is filed for the purpose of showing corrected amount of water, and corrected priority date, all of which were erroneously shown in the original declaration which was filed by Mr. McCaw without an adequate basis in fact. This well is known as the "Dent Well". *¶ 4: 0.379 a/f/a evaporation from the overflow tank, three acre feet consumed from the stock tank supplied by the well.

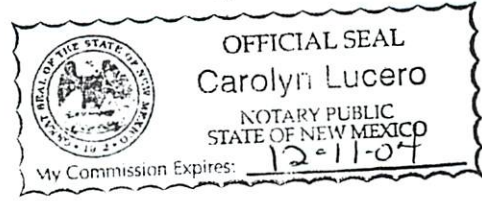
