- 1. A concise summary statement of the party's claims or defenses in this Subproceeding, to be inserted under Heading II in the [Proposed] Scheduling Order. For the sake of simplifying the structure of the proposed order, parties who are represented by common counsel – and who have not plead substantially different positions with respect to the claims asserted in this Subproceeding by the United States and the Zuni Indian Tribe – are requested, but not required, to provide a consolidated statement to be included in the proposed order under a subheading in the form "Parties Represented by [name of the common counsel]." - 2. Any objections or other comments concerning the draft [Proposed] Scheduling Order. In particular, discovery subjects now listed in Sections IV.A.1 and IV.B.1., and anticipated fields of expert testimony now listed Sections IV.A.2.a) and IV.B.2.a), of the draft order are offered as examples and are intended to be altered or supplemented by input from the parties.
